#### Network Access Plan – Highmark WV PPO Network

Pursuant to the West Virginia Network Access and Adequacy Act (the "Act") W.Va. Code § 33-55-1 et seq., and WV Legislative Rule 114-100 et seq. (the "Rule(s)"), Highmark West Virginia Inc. d/b/a Highmark Blue Cross Blue Shield West Virginia ("Highmark WV") submits to the West Virginia Offices of the Insurance Commissioner ("WVOIC") the following revised Network Access Plan for the Highmark West Virginia PPO Network ("Access Plan").

For purposes of Highmark WV's submission under the Act, the Highmark WV PPO Network (the "Network") covers the entire state of West Virginia. This Network is leveraged by the following Highmark WV product categories that are subject to the Act\*:

- Individual (direct pay)\*\*
- Small Group
- Large Group

\*These plans may include dental and/or vision benefits, but these benefits would not qualify as a standalone or limited scope dental or limited scope vision plan as defined in 114 CFR 100-2.11 and 2.12. \*\*The Network also applies to all Highmark WV EPO individual (direct pay) plans which do not have out-of-network benefits except in the cases of emergency and/or approved exceptions. For the avoidance of doubt, the PPO Network is the same network utilized by the EPO plans.

#### Section I. Network Access Standards

A. The Access Plan document that is to available to any person upon request. W. Va. Code §33-55-3(e)(2) & W. Va. Legislative Rule §114-100-4.4

The Access Plan will be available to any member of the public via the Highmark WV website address: <a href="https://highmarkbcbswv.com">https://highmarkbcbswv.com</a>. It is Highmark WV's intention, upon approval from the WVOIC, to provide a reader-friendly summary that will include a weblink to the full Network Access plan, as proposed to the WVOIC.

B. A description of the network and how telemedicine, telehealth or other technology may be used to meet network access standards. W. Va. Code §33-55-3(f)(1) & W. Va. Legislative Rule §114-100-4.8.1

All of Highmark WV's health benefit plans include telemedicine and telehealth benefits. Highmark WV also complies with West Virginia state telehealth laws, which not only permit various forms of technology to be used for telemedicine or telehealth encounters, but also requires that such visits are reimbursed in parity with like services that were performed in the traditional inperson encounter between a provider and a patient.

Highmark WV members have unlimited access to telehealth and telemedicine benefits. In the wake of the COVID-19 pandemic, most providers have necessarily modified their existing patient practices to create more opportunities for patients to seek care via telephone or video methods when the provider believes it is appropriate. Highmark WV intends to apply the Network Access and Adequacy time/distance requirements based on the member's residence, and will not suspend those requirements simply because there is a provider in West Virginia willing to conduct a video encounter with a member regardless of where the member may reside. Additionally, Highmark WV understands that there are some conditions and services that cannot be treated or managed via telehealth/telemedicine. Accordingly, the Network Access and Adequacy time/distance requirements would apply, and members can request to obtain service out of network should the Highmark WV PPO Network not have a provider within the applicable time/distance standards.

C. The Highmark WV PPO Network has an adequate number of providers and facilities within a reasonable distance of covered persons. W.Va. Legislative Rule §114-100-4.8.3.

Highmark WV has established standards to ensure that the plan maintains a network of appropriate practitioners/providers that is supported by written agreements and is sufficient to provide reasonable access to all covered services. These standards take into consideration anticipated enrollment, expected utilization of services, and the specific characteristics and health care needs of the enrolled populations. The standards also consider the number and types of practitioners/providers needed to provide the contracted services, open/closed practices, and geographic distribution. These standards apply to the Network's hospitals, physicians (primary care, behavioral healthcare (BH), high volume and high impact specialty care (including essential community providers-ECPs) and align with National Association of Insurance Commissioners (NAIC Network Access and Adequacy Model Act) and State requirements. Provider network adequacy is assessed at least annually according to the NAIC Network Access and Adequacy Model Act and West Virginia state requirements for geographic distribution and provider to member density ratio only. In order to ensure accuracy in the Network's provider directory, updates are made on an ongoing basis as information is received by Highmark WV.

Interventions and alternative arrangements are implemented to address any barriers/opportunities identified as needed. This includes, but is not limited to, practitioner/provider recruitment and authorization of covered services to non-participating providers due to access issues. In accordance with W.Va. Code § 33-55-1 et seq, and Title 114-100, Highmark WV has implemented policies and procedures to assure that a covered person obtains a covered benefit at an in-network level of benefits from a non-participating provider. These procedures are addressed in the Certificate of Benefits booklets that are available to all Highmark WV covered persons.

To provide more clarification, in the event a deficiency is identified within the network following a network assessment, a market report is generated that includes providers who are in other Highmark regions' networks, out of area providers who practice in contiguous counties, and providers Highmark WV does not have a contract. Identified providers within the time and distance standards are used by the Provider Relations team for recruitment into Highmark WVs PPO network. If a provider is interested in joining the network, Provider Relations follows their established process for obtaining a completed signed contract. Once a signed contract is received, it follows the Highmark WV credentialing process. If recruitment efforts are not successful, alternative arrangements are made available for members to receive covered services (i.e., provisions of covered services through other practitioner/provider types/providers within the time/travel distances, such as availability of primary care physicians to provider certain services

such as allergy and immunology/dermatology care. Telemedicine/telehealth services will also be available. Should reasonable alternative measures not exist, members will be permitted to obtain medically necessary, covered services from out of network providers as though the services were performed by an in-network provider. Further, the member will only be responsible for their applicable in-network member cost share and may not be balance billed.

Additionally, as part of our network management, Highmark WV has relationships with local and national associations/boards of medicine and psychiatry, and we utilize these partnerships when we are establishing a provider network. Highmark WV members may also take advantage of the BlueCard Program, a national program that enables members of one BCBS Plan to obtain healthcare service benefits while traveling or living in another BCBS Plan's service area. The program links participating healthcare providers with the independent BCBS Plans across the country and in more than 200 countries and territories worldwide through a single electronic network for claims processing and reimbursement. The program permits providers to submit claims for patients from other BCBS Plans, domestic and international, to the Member/covered person's local BCBS Plan. As it relates to Network Access, should a Member seek services from a network provider of another BCBS Plan, those services would be treated as though they were received from a provider in Highmark WV's PPO Network and the in-network allowance would be applied subject to any applicable Member Cost-share amounts.

D. Documentation identifying specific provider and facility types within the network per West Virginia county. W. Va. Legislative Rule §114-100-4.8.4

Please visit the Highmark WV Provider Directory, wherein individuals can search available network Providers by County. Any individual can contact the non-dedicated line that is available via a general web search or via the Yellow Pages, 1-888-809-9121.

Please see Appendix II, *Provider Specialties by County Report-Professional and Facility*. This Report provides a listing of every provider specialty credentialed in the Highmark WV PPO Network organized by West Virginia county.

E. A description of the procedures for making and authorizing referrals within and outside its network. This description should address procedures regarding: the provision of a comprehensive listing of the participating providers and facilities to covered persons and primary care providers; the timely referrals for access to specialty care; the expedited referral process; and the process for members to access services outside the network. W. Va. Code §33-55-3(f)(2) & W. Va. Legislative Rule §114-100-4.8.7 (a-d).

Highmark WV health benefit plans do not require referrals, nor do they require that Members designate a primary care physician. Members are permitted to seek care from any provider of their choosing. Notwithstanding, Members are instructed via their applicable Healthcare Certificate of Benefits (the "Certificate") that they will receive greater benefits by seeking Covered Services from

Network Providers (also referred to as "participating" or "in network"). The following is an example of an excerpt that appears in the Certificates<sup>1</sup>:

The choice of a Provider is solely yours. Your PPO plan gives you freedom of choice. You are not required to select a primary care Physician to receive covered care. Please note that while you or a family member can use the Services, including behavioral health and well-woman care, of any Network Physician or Specialist without a referral and receive the maximum coverage under your benefit plan, you are encouraged to select a personal or primary care Physician. This helps establish an ongoing relationship based on knowledge and trust and helps make your care consistent. Your personal Physician can help you select an appropriate Specialist and work closely with that Specialist when the need arises. In addition, primary care Providers or their covering Physicians is on call 24/7.

All Providers are designated as either Network or Out-of-Network. The amount of benefits that you will receive for Covered Services will vary depending upon whether the Provider is in the Network or not. Your financial responsibility will also vary between these Provider designations.

Examples of Providers include but are not limited to the following: primary care Physicians; Specialists; mental health and Substance Use Disorder Providers; community and specialty Hospitals; and laboratories. You have access to care 24 hours a day/7 days a week. If you have Covered Services outside of your primary care Physician's hours, you should follow up with them after receiving care.

You will receive greater benefits by seeking Covered Services from Network Providers. This section tells you how much we will pay for Covered Services at Network and Out-of-Network Providers.

Highmark WV's Provider Directory is accessible by the public. The Provider Directory clearly denotes whether a particular provider is participating in the Highmark WV PPO Network. Highmark WV does not "tier" or group providers in such a way that there are multiple levels of innetwork providers that may have higher allowances than other in-network providers, depending on the applicable tier. Members can search the Provider Directory generally, or they are able to search providers who are their specific plan via the search features/filters within the Provider Directory. Highmark WV is compliant with the requirement that at least seventy percent (70%) of the providers in the Highmark WV PPO Network are accepting new patients. Please see Section IV., Provider Directories for more specific information regarding Highmark WV's Provider Directory.

Primary care providers are generally not provided with a comprehensive listing of network providers and it is instead expected that they would access this information by visiting the Highmark WV online provider directory, or the provider may contact Highmark WV Provider Relations for assistance. Highmark WV encourages its providers to avoid referring Members to out-of-network providers. However, understanding that this may not always be avoidable, Highmark WV does not take any adverse action against a provider or their network status. Members

are permitted to seek care from any provider they wish, as was noted in our previous submission. If the Member's plan does not include out-of-network benefits (absent emergency or approved exceptions) or the Member's plan features out-of-network coverage but the Member believes there to be a network inadequacy issues, the Member can seek an exception request to have the services paid as in-network.

F. A description of the documented, quantifiable and measurable process for monitoring and assuring the sufficiency of the network in order to meet the health care needs of covered persons on an ongoing basis. W. Va. Code §33-55-3(f)(3) & W. Va. Legislative Rule §114-100-4.8.5.

Highmark WV monitors the Network on at least an annual basis in its Annual Assessment of Practitioner/Provider Availability. In the event Highmark WV determines that there is a gap in the network, such that a certain provider is not available at all, or that provider type is not available within the applicable time/distance standards, the following steps are taken to ensure access to needed services:

- Other provider types are identified to perform some services for the provider where the gap is identified.
- Non-participating provider reports are reviewed to see if any non-participating providers are available for recruitment in counties where gaps have been identified.
- Highmark will authorize out of network services to pay at the in-network rate if the network is deemed insufficient.

Highmark WV's annual assessment efforts permit it to make corrective actions, such as initiating the recruitment of providers in West Virginia. Likewise, Highmark WV also responds to trends or complaints that it receives throughout the year with respect to network sufficiency and responds accordingly. Additionally, please refer to the statements contained in item C. above.

G. A description of the process to assure that a covered person is able to obtain a covered benefit, at the in-network benefit level, from a non-participating provider should the carrier's network prove to not be sufficient. This description should Include actions taken to ensure covered persons are not balance billed and how in-network benefit levels benefits are actually calculated, including allowable amount determinations and the process for updating plan accumulators. W. Va. Legislative Rule §114-100-4.8.6.

Highmark WV complies with this Legislative Rule and has implemented a process to ensure that a Member can obtain a covered benefit at the in-network level of benefits from a non-participating provider ("out-of-network provider").

Highmark WV acknowledges that while certain deficiencies may exist within its Network, it has established robust procedures and mechanisms to address these deficiencies and remedy them to the best of our ability. Highmark WV relies on geo-access reporting to determine whether the network is insufficient along with the parameters for time and travel distance as set forth in the Network Access and Adequacy Act. When it is determined that there is a deficiency, Highmark WV will review the Non-participating Provider report to identify whether there are non-participating providers available for recruitment in counties where the deficiency was identified. Highmark WV will authorize out of network services to pay at the in-network rate if the network is deemed insufficient.

The process to obtain covered services from an out-of-network provider requires a Member's selected provider or primary care provider to request an exception ideally pre-service, but they may also request an exception post-service. With respect to criteria, as with any claim (or planned services) the service(s) at issue must be medically necessary *and* be Covered Services under the plan. Once those two criteria are satisfied, it would then become a question of whether the member can access an in-network Provider to perform the service(s) at issue within applicable travel time/distance standards under the Act. Should the analysis determine that there is no such innetwork Provider, the exception request would be approved, and the Member will be notified by telephone and/or letter. In the event that there is an in-network Provider, the Member will likewise be notified by telephone and/or letter to explain the determination and to assist the Member in making contact with the in-network Provider(s) identified by Highmark WV. The Member, again, may still choose to receive services by the out-of-network Provider, but for purposes of payment, any reimbursement will be subject to the benefits available under the Member's applicable plan.

Highmark WV has included a provision in the Member-facing Certificates that instructs Members how they can obtain services at the Network level of benefits in the event of Network gaps. The following is an example of the pertinent language from the Large Group products Certificate. Note, however, that EPO products do not include Out-of-Network benefits except in the cases of emergency and approved exceptions.

# Out-of-Network Provider Exception (does not include Emergency Care Services).

While your Plan provides benefits whether you use Network or Out-of-Network Providers, your Provider may request to obtain Covered Services from an Out-of-Network Provider in the following instances:

- a. When Highmark WV does not have a type of provider available to provide a Covered Service;
- b. When Highmark WV does not have a sufficient number of Network Providers available to provide a Covered Service; or
- c. When Highmark WV does not have a Network Provider available without unreasonable travel or delay.

If the exception request is approved, the benefit will be based upon the Provider's Actual Charge. If approved your deductible, coinsurance and cost-sharing will be no greater than if the provider had been In-Network and will be included in the Maximum Out-of-Pocket amount. To request an approved exception, have your Provider contact Highmark WV at the number on the back of your ID Card and follow the prompts.

Once Highmark WV receives a claim for covered services that were performed by a provider pursuant to an exception under this Rule, the claim will be paid according to the provider's charged amount. If necessary, Highmark WV Provider Relations will initiate negotiation efforts with the out-of-network provider; however, the Member's liability will not be impacted by the outcome of these negotiations, as the Member will only incur liability that is consistent with the cost-sharing amount(s) that would apply had the covered services been performed by a Network provider, i.e., the claim will process as though it were an in-network claim. Highmark WV will ensure that the

Member is not balance billed for the difference between Highmark WV's payment and the provider's charged amount.

H. A description of each the factor used to build the provider network, including a description of the network and the criteria used to select providers. W. Va. Code §33-55-3(f)(4) & W. Va. Legislative Rule §114-100-4.8.2.

Highmark WV's Network consists of a full range of primary care and specialist clinicians, and hospitals. When developing the Network, consideration is made of the location of all types of clinicians and hospitals in relation to where our members live. Highmark WV's goal is for all Members to have access within a reasonable distance to all types of clinicians and hospitals.

Highmark WV complies with West Virginia's Any Willing Provider statute when building its network. Providers must satisfy applicable credentialing requirements as set forth by law and accrediting bodies/agencies and Highmark WV to be eligible Network Providers. Upon successful completion of the credentialing process, providers will execute the applicable Highmark WV Network Provider agreement(s).

Processes have been established to: conduct timely verification of credentialing/recredentialing information through primary sources, unless otherwise indicated, within prescribed time limits; obtain information from providers that may adversely impact their ability to provide care; verify sanction activity that may impact their ability to provide safe and appropriate care to members; and conduct timely recredentialing to identify changes since the last credentialing cycle which may affect the care provided to members: The credentialing process will be completed prior to the effective date of the provider's contract. The following components are important to highlight regarding Highmark WV's Credentialing Process:

Initial Credentialing. Highmark must credential providers and utilize procedures to comply with National Committee for Quality Assurance (NCQA), the Centers for Medicare & Medicaid Services (CMS), and the state of West Virginia. Providers are initially credentialed prior to network admission and recredentialed at least every three years. Highmark utilizes ProView, the standardized national online credentialing system developed by the Council for Affordable Quality Healthcare (CAQH), as our exclusive provider credentialing system. All Highmark network providers must use the CAQH ProView™ system for credentialing and recredentialing. Providers will be initially credentialed within one hundred twenty (120) days following the submission of the provider's completed credentialing application, in compliance with W.Va. Code § 30-45-2(11), unless the provider's primary site of practice is located in Ohio, in which case the Ohio Healthcare Simplification Act requires that initial credentialing be completed within ninety (90) days.

The initial credentialing process includes, but is not limited to:

- Completion of a CAQH online application
- Signed attestation verifying all information on the application and stating any reasons for inability to perform essential duties, lack of illegal drug use, loss of license/privileges, felony, and disciplinary action
- Primary source verification
- Inquiry to National Practitioner Data Bank for sanction history
- Other verification as needed

The following is a general summary of Highmark's credentialing criteria for all practitioners.

- Active state license in each state in which the practitioner provides services;
- Acceptable five-year work history for initial credentialing;
- Professional liability insurance in compliance with regulations in state(s) in which the physician practices (please see the section in this unit on malpractice insurance requirements);
- Acceptable malpractice history;
- Have not opted out of the Medicare Part B program for the Medicare Advantage network(s) (PA, DE, and WV); and
- No Medicare or Medicaid sanctions. In addition, physicians (MDs, DOs, DDSs/DMDs, and DPMs), Physician Assistants, CRNPs, Clinical Nurse Specialists, and Nurse Midwives must furnish proof of the following:
  - O Active Drug Enforcement Agency (DEA) certificate in each state in which the practitioner is prescribing controlled substances or a plan of action listing an in-network provider who could prescribe on their behalf, if applicable;
  - O Privileges at a network or participating Blue Cross Blue Shield hospital, as applicable; and
  - Availability to see Highmark members at least twenty (20) hours a week (for primary care practitioners).
  - o Highmark requires that all credentialed network practitioners provide coverage for members twenty-four (24) hours a day, seven (7) days a week, unless exempted. This can be accomplished either directly or through an on-call arrangement with another Highmark WV credentialed participating practitioner of the same or similar specialty and of the same network(s).
  - Additional criteria for Non-Physician Acupuncturist must meet the following requirements:
    - A masters or doctoral level degree in acupuncture or Oriental Medicine from a school accredited by the Accreditation Commission on Acupuncture and Oriental Medicine (ACAOM)
    - A current, full, active, and unrestricted License to practice acupuncture What Is My Service Area;
    - Additional criteria for allied health practitioners include:
      - Evidence of appropriate education and training (licensure often verifies education);
      - Registered nurses (RNs) must have an active advanced practice certification by an entity approved by the state licensing board; and
      - Physician Assistants must have collaborating agreement with a physician who is credentialed and contracted in the same network.

**Recredentialing.** The recredentialing process includes most of the same components as initial credentialing with some added components. At the time of recredentialing, a quality review is conducted. This review includes, when available, member satisfaction, member complaints related to both administrative and quality of care issues, malpractice history, medical record reviews, and office site information. Information regarding clinical quality actions or sanction activity will also be considered for continued network participation.

**Ongoing Monitoring/Verification:** Highmark's Provider Information Management department routinely monitors the ongoing compliance of network providers with credentialing/recredentialing criteria. Such monitoring includes, but is not limited to:

- U.S. Department of Health and Human Services, Office of Inspector General (OIG), List of Excluded Individuals/Entities (providers excluded from participation in Medicare, Medicaid, and other federal health programs) (monthly);
- Licensing Board queries (monthly); and
- Medicare Part B Opt Out List (monthly). If it is determined or suspected that a provider no longer complies with credentialing, recredentialing, or contracting requirements (e.g., revocation or suspension of a license, OIG sanction), the matter will be investigated and presented to the applicable Highmark Network Quality and Credentials Committee (or the medical director in urgent situations) for appropriate action.
- I. A description of efforts made to address the needs of covered persons with limited English proficiency or illiteracy, diverse cultural or ethnic backgrounds, physical or mental disabilities, and serious, chronic, or complex medical conditions. This should include efforts, to include various types of ECPs in its network. W. Va. Code §33-55-3(f)(5) & W. Va. Legislative Rule §114-100-4.8.11.

Highmark WV includes a multi-language and anti-discrimination disclosure in its member-facing materials that instructs the Member to contact the number on the back of their Membership ID card for assistance in their preferred language or if they have physical, intellectual or mental disabilities that would require additional assistance and/or the use of alternative assistive materials or devices. Similarly, the Highmark WV website also includes links by which Members can obtain assistance.

As part of Highmark WV's annual assessment of Practitioner and Provider Availability, Highmark WV conducts an analysis of Physical/Sensory Handicapped Accessibility. The analysis entails obtaining Assistive Aid reports from its Network Providers by county to assess how many practitioners/providers reported that they have assistive aids available to ensure that Members with physical and/or sensory disabilities have access to assistive devices. Highmark WV compares these reports to on-site nurse visit reports and will identify opportunities for improvement

With respect to efforts to include various types of ECPs in its network, please refer to Sections C. and F. above.

J. A description of methods used to assess the health care needs of covered persons and their satisfaction with services. W. Va. Code §33-55-3(f)(6) & W. Va. Legislative Rule §114-100-4.8.10.

As part of Highmark WV's annual assessment of Practitioner and Provider Availability, Highmark WV reviews instances of Member dissatisfaction and Complaints that relate to provider availability and satisfaction with provider services. These complaints are tracked in the Customer Service Desktop. A monthly report is generated and sent to Highmark WV's Compliance Consultant to identify trends and opportunities for improvements, as well as to notify the correct business owners to implement corrective actions, as needed.

Members may also file complaints with the WVOIC or their legislative representatives. Upon notification from the WVOIC or representative that a Member complaint has been filed, Highmark WV investigates the allegations of the complaints and responds to the inquiring party. All complaints are logged and regularly reviewed to identify trends and opportunities for improvements, as well as to notify the correct business owners to implement corrective actions, as needed.

K. A description of methods used to inform covered persons of the plan's grievance and appeal procedure. W. Va. Code §33-55-3(f)(7)(A) & W. Va. Legislative Rule §114-100-4.8.12.a.

Highmark WV Certificates include a detailed description of the plan's grievance and appeals procedure. Additionally, Members may contact Highmark WV Member Services at the number on the back of their Membership ID card for information. Members also have the option to view their Certificates via the Highmark WV website. Members would have to log into their Highmark WV account to see details and information regarding their specific plan.

L. A description of methods used to inform covered persons of the process for choosing and changing providers. W. Va. Code §33-55-3(f)(7)(B) & W. Va. Legislative Rule §114-100-4.8.12.b.

Highmark WV plans do not place any requirements on Members with respect to choosing or changing a provider. Members are not required to designate a primary care physician and are also not required to obtain referrals before seeking treatment. Additionally, Members may contact Highmark WV Member Services at the number on the back of their Membership ID card for information. Members also have the option to view their Certificates via the Highmark WV website. Members would have to log into their Highmark WV account to see details and information regarding their specific plan. Please see Section E for more information about Provider Choice.

M. A description of methods used to inform covered persons of the process for updating provider directories. W. Va. Code §33-55-3(f)(7)(C) & W. Va. Legislative Rule §114-100-4.8.12.c.

Highmark WV includes a web link on both its homepage and Provider Directory page at the bottom of the page to permit Members to contact Member Services via the telephone number on the back of their Membership ID Card to report inaccurate information in the Provider Directory.

N. A description of methods used to inform covered persons of health care services offered, including those services offered through the preventive care benefit. W. Va. Code §33-55-3(f)(7)(D) & W. Va. Legislative Rule §114-100-4.8.12.d.

Highmark WV Certificates include a detailed description of all benefits and covered services available under the plan<sup>2</sup>. Members may contact Highmark WV Member Services at the number on the back of their Membership ID card for information. Members also have the option to view

The Certificate also addresses which specialty medical services are available, including but not limited to physical therapy, occupational therapy, and rehabilitations services.

their Certificates via the Highmark WV website. Members would have to log into their Highmark WV account to see details and information regarding their specific plan.

Members may contact Highmark WV Member Services at the number on the back of their Membership ID card for information. Members also have the option to view their Certificates via the Highmark WV website. Members would have to log into their Highmark WV account to see details and information regarding their specific plan.

P. A description of the process for enabling covered persons to change primary care professionals. W. Va. Code §33-55-3(f)(9) & W. Va. Legislative Rule §114-100-4.8.8.

Highmark WV plans do not place any requirements on Members with respect to choosing or changing a provider. Members are not required to designate a primary care physician and are also not required to obtain referrals before seeking treatment. Additionally, Members may contact Highmark WV Member Services at the number on the back of their Membership ID card for information. Members also have the option to view their Certificates via the Highmark WV website. Members would have to log into their Highmark WV account to see details and information regarding their specific plan. Please see Section E for more information about Provider Choice.

# Section II. Coordination and Continuity

A. A description of the process for ensuring the coordination and continuity of care for its covered persons. W. Va. Legislative Rule §114-100-5.1.

Highmark WV is committed to ensuring that it employs a proactive and seamless approach to managing the healthcare of a Member and to ensure that timely healthcare transitions occur. Highmark WV also complies with CMS and NCQA requirements regarding continuity and transition of care.

#### **Continuation of Care and Transition of Care.**

Opportunities to coordinate care for purposes of Continuation of Care ("COC") or Transition of Care ("TOC") may be identified via the Utilization Management process or via referrals from various sources such as providers, caregivers, the member themselves, as part of discharge planning or medical management program referrals. Also, members with high risk diagnoses, or specific diagnoses, certain discharge planning indicators (such as not being weight bearing or able to perform certain activities of daily living, for example), may present an opportunity for COC/TOC.

Upon identification, the individual Member's case will be evaluated to assess what COC/TOC services may be appropriate and available. A Case Manager will work with the Member, their provider(s), and family as appropriate, to ensure that the necessary services are available or that alternatives are explored in the event certain services are not Covered Services under the Member's plan or the provider is not participating in the Highmark WV network.

# Quality of Care.

Likewise, when issues are identified regarding quality of care, such as through complaints adverse events, or data tracking/analyses, Highmark WV Clinical Quality Staff will investigate the issues raised. The investigation involves review by a registered nurse, medical records review as necessary and other clinical review as necessary. The investigation will determine the *deviation in the standard of care* and assess a Level of Harm. If the deviation in the standard of care is identified as a quality of care issue, the case if then forwarded to the Senior Medical Director, Medical Policy and Quality for determination of corrective action and provided and to the Provider Credentialing for use in the recredentialing process. If the clinical quality of care issue or concern is related to a complication but does not have an adverse outcome, it will be tracked with the appropriate assign descriptor for reporting and analysis of trends in practitioner/provider performance. All practitioners, including specialists, will be tracked to ascertain necessitate additional recredentialing review should there be more than two issues identified per quarter and/or five issues in four consecutive quarters.

Please see the following highlighted features of Highmark WV's Continuity of Care, Transition of Care, and Quality Assurance processes:

- Discharge and Transition planning. Highmark WV Clinical Services team will initiate discharge/transition planning at the beginning of an admission to facilitate a coordinated transition to the next level of care. Discharge/Transition planning involves coordination and collaboration among provider, practitioners, the health plan, the Member and/or the Member's family. The Clinical Services Staff will assist in the authorization and arrangement of services/equipment to be provider. If a benefit is not available under the Member's plan, they may request exceptions or alternatives via the appeals process. The discharge/transition planning process

continues until the Member is transitioned home with coordinated skilled services, community-based services and/or self-directed care.

- Helping Members Select Providers and Vendors. While Highmark WV Members are not required to designate a PCP, they may do so. Members can change their PCP designation by contacting Member Services. Member Services can also assist Members who are transitioning from pediatric care to adult care in locating a new Provider.
- Termination of Provider or Facility. The Highmark WV Continuation of Care ("COC") process allows for a Member to continue an on-going course of treatment with a Primary Care Physician, a specialist, or a facility whose contract has been terminated by Highmark WV for reasons other than for cause. COC is also available through the post-partum period for Members in their second or third trimester of pregnancy. COC process applies to medical and behavioral health services.

Highmark WV will notify impacted Members of the termination of their Provider or Facility, advising them to contact Member Services if they wish to request continued access to their Provider. Requests will be accepted by telephone, electronically or letter to Member Services. Once Member Service has gathered necessary information from the Member and Provider, the Highmark Care Management team will review the request. Members will be notified by mail of Highmark WV's decision and next steps. If the request is denied, Member will be given appeal rights. Member Services will assist the Member in finding a Network provider. Members may also have the option to extend the COC period approved by Highmark WV.

- Transition of Care New Enrollees. Highmark WV complies with WV Law regarding prior authorizations and accordingly will honor the prior authorization of a former insurer for three (3) months.

#### Health carrier insolvency.

In the event of carrier insolvency and/or contract termination, Highmark WV will follow existing insolvency laws and will inform affected individuals via written communication mailed to their address on file.

Highmark WV is a member insurer of the West Virginia Guaranty Association and complies with the West Virginia Guaranty Association Act. Members are notified of the general purpose and their potential rights under the Guaranty Association Act via a mandatory notice in the Certificates.

#### **Section III. Provider Directories**

The Highmark WV Provider Directory is available via Highmark WV's website at, <a href="https://highmarkbcbswv.com">www.https://highmarkbcbswv.com</a>. Once on the homepage, any person can view the Provider Directory via a link at the top of the homepage titled, "Find a Doctor or Pharmacy." All Provider Directories maintained by Highmark WV are accessible via this link. Any person may view all of the current providers without having to create or access an account or requiring the entry of a plan

or policy number. The electronic Provider Directory also reflects a disclosure at the bottom of the webpage with the date of the most recent update of the Provider Directory.

Printed versions of the Provider Directory, or portions thereof, may be obtained via the Highmark WV website directly, or a Member may contact Highmark WV Members Services at the number on the back of their Membership ID card. Membership Services can print and mail or email excerpts of the Provider Directory or a full copy. Persons from the general public can also contact Highmark WV via the contact information listed on the website at the bottom of the screen. Any individual can contact the non-dedicated line that is available via a general web search or via the Yellow Pages, 1-888-809-9121. Requests for printed directories or portions thereof are provided within five (5) business days.

Per the Provider Manual which is incorporated by reference into the Highmark WV Provider Agreement(s), Providers are required to maintain accurate and up-to-date information regarding their practice locations and licensure. Providers should report changes to Highmark WV as soon as possible. Providers are required to verify their information in NaviNet and make necessary updates at least every quarter. Providers who do not verify or update their information timely will be removed from the Provider Directory. Highmark WV updates the Provider Directory within three (3) days of receipt of notification of a change in Provider information. Such changes will be reflected in both the electronic and paper Provider Directories.

- B. A description of the process for auditing provider directories, including document retention and steps taken to ensure all entries in a provider directory will be audited at least once every eighteen months.

Highmark WV conducts audits of the Provider Directory at least quarterly. A semi-annual audit is conducted in accordance with NCQA standards CR1: Credentialing Policies Element A, Factor 11 and Net 5: Physician and Hospital Directories Elements C, D, and G. (NCQA standard numbers are subject to change by NCQA.) Highmark WV's goal is 100% accuracy of its existing date in the Provider Directory or after investigation and correction of inaccurate data. The audit reviews a random sampling of twenty (20) of each of the following provider types and reviews currently credentialed practitioners/organizations:

- Family Practice PCP
- Internal Medicine PCP
- Pediatrics PCP
- General Practitioner PCP
- OB/GYN
- Other Specialists
- Facilities

**Additional Quarterly Reviews:** Highmark WV also conducts quarterly audits of all providers on Highmark WV's practioner directory. The platform in which the directory sits is facilitated by the vendor Sapphire Digital.

The audits ensure that listings in practitioner directories and other materials for members are consistent with the credentialing data, including specialty, and demographic information including office location, phone number, and acceptance of new patients. Outreach to all providers is conducted in one of two avenues quarterly.

- Atlas Systems Outreach In 2017, Highmark West Virginia contracted with Atlas Systems to conduct quarterly outreaches on Highmark's behalf for data validation. Every quarter a provider file is generated by Highmark based on practitioner's group affiliations and locations. The file is sent to Atlas Systems to verify the following data elements: practitioner name, specialty, practice locations, phone numbers, and patient acceptance status. Atlas sends back (twice weekly) files so Highmark WV can process any data changes. The providers can attest to their data through a phone call to the office locations or they can verify their data through Atlas' self-service portal, PrimeHub. The files received from Atlas are assigned to Highmark staff to update the changes in the provider files. Once the changes have been completed, the updates will display in the Highmark WV online directory as part of the weekly refresh updates.
- <u>Highmark WV Roster Outreaches</u> Starting in 2018, a subset of WV practioner outreaches were conducted via a new roster process sent out by Highmark WV. The rosters are an excel document that contains the entity's provider data inclusive of: Practitioner Id numbers, specialties, Group Id numbers, addresses, phone numbers and questions that need answered by the providers to verify their data.

\*As of January 1, 2021, Cabell Huntingdon, Weirton, Wheeling, and West Virginia University were the four health systems that utilized the roster process. All other practitioners were included as part of the Atlas Systems Outreach process.




The federal No Surprises Act includes more rigorous requirements with respect to provider directory accuracy that became effective as of January 1, 2022. Highmark WV has revised its processes to satisfy the NSA's requirement that plans conduct provider outreach to verify directory accuracy on five components every ninety (90) days. The data elements that need to be audited are name, address, phone, specialty, and digital contact information.

#### 114-100-7. Provider Directories

7.2.5.a.) In plain language, a description of the criteria the carrier has used to build its provider network:

Highmark WV Response: All of Highmark WV's networks consist of a full range of primary care and specialist clinicians, and hospitals. When developing our networks, consideration is made of the location of all types of clinicians and hospitals in relation to where our members live. Our aim is for all members to have access within a reasonable distance to all types of clinicians and hospitals.

Highmark WV has established standards to ensure that the plan maintains a network of appropriate practitioners/providers that is supported by written agreements and is sufficient to provide reasonable access to all covered services. These standards take into consideration anticipated enrollment, expected utilization of services, and the specific characteristics and health care needs of the enrolled populations. The standards also consider the number and types of practitioners/providers needed to provide the contracted services, open/closed practices, and geographic distribution. These standards apply to the Network's hospitals, physicians (primary care, behavioral healthcare (BH), high volume and high impact specialty care (including essential community providers-ECPs) and align with National Association of Insurance Commissioners (NAIC Model of Care) and State requirements. Provider network adequacy is assessed at least annually according to the NAIC Model of Care and West Virginia state requirements for geographic distribution and provider to member density ratio only.

Highmark WV complies with West Virginia's Any Willing Provider statute when building its network. Providers must satisfy applicable credentialing requirements as set forth by law and accrediting bodies/agencies and Highmark WV to be eligible Network Providers. Upon successful completion of the credentialing process, eligible providers will execute the Highmark WV Network Provider agreement(s). Examples of credentialing requirements include:

#### 1. Verification of licensure

- 2. Board Certification verification
- 3. Verification of Education
- 4. Review of liability claims history

Processes have been established to: conduct timely verification of credentialing/recredentialing information through primary sources, unless otherwise indicated, within prescribed time limits; obtain information from providers that may adversely impact their ability to provide care; verify sanction activity that may impact their ability to provide safe and appropriate care to members; and conduct timely recredentialing to identify changes since the last credentialing cycle which may affect the care provided to members: The credentialing process will be completed prior to the effective date of the provider's contract.

(7.2.5.d.) If applicable, in plain language, a description of the criteria the carrier has used to tier providers; If applicable, in plain language, how the carrier designates the different provider tiers or levels in the network and identifies for each specific provider, hospital, or other type of facility in the network which tier each is placed, for example by name, symbols, or grouping, in order for a covered person or a prospective covered person to be able to identify the provider tier; and

Highmark WV Response: Highmark WV does not offer plans to the commercial insured market that features "tiering." Highmark WV does participate in programming offered through the Blue Cross Blue Shield Association called "Blue Distinction." This program does not create separate networks. This is simply a designation available to providers and facilities when they meet certain quality and efficiency standards in delivery of care for complex conditions. The Provider Directory will include an icon to denote a Blue Distinction designation if the provider or facility qualifies for such designation.




